



## Terms and Conditions – Loreto Parents & Friends Tuition Raffle

The Loreto Nedlands Parents & Friends Committee (Loreto Nedlands P&F) is pleased to offer the 2022 Tuition Raffle. You could win your 2022 Loreto Nedlands school fees, up to the value of \$6,000, for one child.

All proceeds from the draw will be used by the Loreto Nedlands P&F Committee to support the continuous enhancement and development of the school.

### Lottery Permit:

The Loreto Nedlands Tuition Raffle 2022 (Raffle) is being conducted pursuant to lottery permit *LS217669821* (issued by Gaming and Wagering Commission on 19 October 2021). The Permit is held by Sarah Whitehouse, A member of the Loreto Nedlands P&F Fundraising Committee, on behalf of Loreto Nedlands P&F (69 Webster Street, Nedlands WA 6009) to conduct and promote the Lottery in Western Australia.

### Promotion Period

*Tickets will be available from Monday 25th October at 9am AWST until Tuesday 30 November 2021 5pm AWST (unless sold out prior). The prize will be drawn at the Loreto Nedlands P&F AGM on Wednesday 1st December 2021 at 6:30pm AWST*

## Terms and Conditions

Purchasers must be 18 years or older. Tickets are \$50 each\*. A maximum of 500 tickets will be sold.

There is no limit on the number of tickets that can be purchased by each individual Purchaser (subject to the overall ticket limit of 500).

Proceeds from the sale of the Raffle tickets will go towards the Loreto Nedlands P&F fundraising fund.

The winner will be notified via telephone or email. Results to be published in the <https://loretonedlands.wa.edu.au/communication-news/> on 02 December 2021 and a copy of the publication detailing results to be lodged with the financial return.

Loreto Nedlands P&F and Loreto Nedlands school may use a prize winner's details for promotional purposes. By purchasing a Raffle ticket, the Purchaser agrees that if the Purchaser is a prize winner, the Purchaser will participate in reasonable media activities concerning the Raffle draw and to photographs or video of the winner being used for the Loreto Nedlands P&F and Loreto Nedlands school marketing and promotional activities (both in print and on the internet).

The Raffle draw is subject to a required minimum number of tickets being sold, as determined by Loreto Nedlands P&F. If the required minimum number of tickets are not sold by the closing date, the Raffle will be cancelled and all monies refunded in full to Purchaser, subject to the approval of and any conditions imposed by the Department of Racing, Gaming and Liquor WA.

### Main Draw

Assuming all tickets are sold, each ticket has a 1 in 500 chance of winning the prize. The prize value is up to \$6,000 in fees only, for one child only, for the 2022 WA school year

Prize value is for one child's, one year tuition up to \$6,000 value. Once Loreto Nedlands fees for 2022 have been confirmed, the amount of the school fees for the winners child will be credited to the 2022 account of the winner's choosing. If the winners child's 2022 fees are above \$6,000 anything over this amount will not be covered.

The prize must be redeemed for use during the 2022 WA school year only.

Unused balances cannot be redeemed for cash and are not refundable in any portion.

If the winner so chooses, the prize may be donated to the school for contribution to the Loreto Nedlands P&F fund to be allocated at the Loreto Nedlands P&F's discretion.

Prize is not transferable or redeemable in cash.

### **Conduct of Draw**

The prize draw will be conducted by Rika Andres, Principal of Loreto Nedlands at the *Loreto Nedlands P&F AGM on Wednesday 1st December 2021 commencing at 6:30pm AWST* by means of a barrel draw.

Unclaimed prizes will be dealt with in accordance with the procedures set out in the Gaming and Wagering Commission Act 1987 (WA).

**Refunds:** Refunds can only be processed prior to the date of the prize draw. Requests for refunds will need written approval of the Department of Racing, Gaming and Liquor WA. This process may take a number of weeks. Refunds cannot be issued after the prize draws.

**Changes:** Where it is lawful to do so, these Terms and Conditions may be updated to address any errors or to clarify information and re-published online at <https://loretonedlands.wa.edu.au/communication-news/> or otherwise as required by the requirements of the Permit or the Department of Racing, Gaming and Liquor WA.

**Excluded purchasers:** Tickets must not be purchased by the Lottery Permit Holder. During the conduct of a draw, if the Loreto Nedlands P&F (or delegate) conducting the draw determines that the Lottery Permit Holder is a prize winner, then the relevant prize will be re-drawn. If the Loreto Nedlands P&F (or delegate) determines after the conclusion of the draw but before a prize has been collected that the Lottery Permit Holder is a prize winner, then the excluded purchaser will not be entitled to collect the prize.

The decision of the Loreto Nedlands P&F (or delegate) will be final and binding.
